## Enhanced income-based rebates

Households at 0%–250% of the federal poverty level (FPL) are eligible for a **\$350 (Tier 1)** or **\$475 (Tier 2)** rebate, depending on equipment efficiency ratings. Households at 0%-200% may qualify for free [WRAP assessment](#).

The FPL is calculated based on household size and income.

### Product eligibility

- ASHP must be ENERGY STAR® certified.
- Rebates are not available for new construction.
- Confirm product eligibility by visiting ENERGY STAR certified air-source heat pump page at [energystar.gov/productfinder/product/certified-heat-pumps](http://energystar.gov/productfinder/product/certified-heat-pumps).
- Eligible systems must be rated in the AHRI heat pumps database. AHRI certificates for eligible HVAC systems must include all components: indoor coils, outdoor coils, furnaces, etc. AHRI ratings for individual components of a system will not be considered valid. Your contractor should be able to help you obtain the AHRI certificate number to complete this form.
- **If the account is a business, you may be required to provide business type, tax status and W-9.**
- Heat pump must have a capacity < 65 kBTU/hr.
- Equipment already rebated via midstream or instant discount channel does not qualify for additional incentives
